- The export of the equidae listed in the Schedule is permitted without the detention and rest at approved premises immediately before export as required by the Export of Horses (Protection) Order 1969.

Declaration

I, the undersigned, declare that:

- it is my responsibility, as the person presenting the equidae for inspection, to ensure that they are accompanied by approved passports. I understand that equidae presented without passports will not be inspected and will not be eligible for export
- I understand that this declaration does not grant exemption from the requirements of the Welfare of Animals (Transport) (England) Order 2006, the Welfare of Animals (Transport) (Scotland) Regulations 2006, the Welfare of Animals (Transport) (Wales) Order 2007 or any other legislation
- I will surrender this declaration to the master of the vessel/pilot of the aircraft, or their representative, at the time of shipment
- each equidae listed in the Schedule is intended for breeding, riding or exhibition
- I understand that any domestic equidae of 147cms or less which is not accompanied by a valid Export Health Certificate and/or Intra Trade Animal Health Certificate or Commercial Document (DOCOM), must be inspected within 48 hours prior to departure by an Official Veterinarian (OV) and certified in writing (by that OV) as being fit to be transported on the intended journey in accordance with the provisions of Council Regulation (EC) No. 1/2005. In order to arrange this I understand and confirm that I am responsible for and must contact the Animal and Plant Health Agency (APHA) at least 48 hours prior to departure from the inspection premises and arrange for the equidae to be inspected. I confirm that inspections can and will only be arranged at premises with suitable facilities
- to the best of my knowledge and belief the particulars given above and in the Schedule are correct
- I understand that making this declaration does not confer any consent or approval that maybe required under any other regulations in connection with this export.
